TEMPORARY PROHIBITION OF THROUGH TRAFFIC

DEVON COUNTY COUNCIL hereby give **NOTICE** that:

From **MONDAY 29 SEPTEMBER 2025**
for a maximum of 5 days

Until **TUESDAY 30 SEPTEMBER 2025** (both dates inclusive)

Between the hours of **09:30** and **14:30**

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads.
